Please note: Minimum 30 FULL DAY campers per week are needed to conduct camp.

Deposit Required

A deposit of \$50 is required along with registration forms on or before Friday, April 24, 2009. The \$50 will be applied to the camper's first week of tuition. The deposit is NON REFUNDABLE.

An additional \$20 deposit is required for each week that a child is being signed up for. This deposit is non-refundable and non-transferable without proper 2 weeks written notice.

Payment Schedule

FULL PAYMENT for weeks enrolled must be paid on or before Friday, May 15, 2009, and a 10% discount will be given. Example: \$ 250 less 10% = \$225. Payment received after this date is subject to full price.

Refunds

Refund requests will be honored prior to June 19, 2009, but will be subject to a \$50 processing fee. Refunds WILL NOT be given beyond June 19, 2009. NO REFUNDS are given for days absent, regardless the reason.
